HAPPY CENTENARY BIRTHDAY TO OWEN OWEN, CLAYTON SQUARE

In November 2025, Clayton Square will be 100 years old, and whilst no longer Owen Owen, it is still a busy retail department store as part of the Flannels group. To celebrate the centenary the Trust is organising a display in the Liverpool Central Library, with photos and items commemorating the man, the store and his legacy. The exhibition will open in September 2025 and will run until the end of the year.



The Trust itself has now been in existence for an amazing one hundred and twenty three years and is still working to help former staff and their families who are in financial need. This year, with the removal of the Winter Fuel Payment from pensioners who do not receive pension credit, it is now more important than ever to make sure you are receiving all the benefits that you are entitled to. It is not too late to apply for pension credit, and if you are successful, the Winter Fuel Payment will be paid retrospectively. Even a small amount of pension credit will allow you to claim - not just the winter fuel payment - but also to get help with things like glasses and dentistry. The Government website has a lot of information about benefits (<u>www.gov.uk/pension-credit</u>) and Age Concern offers advice on how to claim pension credit, online and in person. So if you think you might be entitled to more help, please call your local office for help and advice.

If you already receive a grant from the Trust do remember that you can apply for extra help with repairs and renewals, replacement white goods, electricals or furniture. Please call the Trust office before you go ahead, to check whether it is something we can help with.
